HERE FOLLOW THE COSTS FOR THE REIMBURSEMENT OF EXPENSES FOR SERVICES RELATED TO THE AUTHENTICATION AND THE ARCHIVIATION OF THE WORKS BY THE ARTIST LUIGI VERONESI:

- 250,00 EURO (+ VAT) for works on canvas and panel
- 150,00 EURO (+ VAT) for works on paper and photographic works

THE AUTHENTICATION AND THE ARCHIVIATION PROCEDURE WILL BEGIN ONLY AFTER RECEPTION OF THE MATERIAL ASKED FOR AND THE RELATIVE BANK TRANSFER PAYMENT. EVEN IF THE WORKS CANNOT BE ATTRIBUTED TO THE ARTIST LUIGI VERONESI, THE PAYMENT CANNOT BE REIMBURSED: IN THIS CASE THE APPLICANT WILL RECEIVE A LETTER SENT BY THE LUIGI VERONESI COMMITTEE WHICH WILL INDICATE THE REASONS FOR WHICH IT WAS NOT POSSIBLE TO ISSUE A CERTIFICATE OF AUTHENTICITY.

**WE WOULD REMIND YOU THAT:**

The Luigi Veronesi Committee, presided over by Elisabetta Rossini, wife and sole heir of Silvio Veronesi, is the body authorised to issue authentications for all the works by the artist. The committee is the body authority for judgements about the works by the artist Luigi Veronesi and for issuing certificate of authenticity for them.

The certificate of authenticity with the archiviatiion certificate will be drafted, stamped, signed, and emitted by the Luigi Veronesi Committee within 60 days of the email confirming the arrival of the material and the bank transfer and the receipt for the reimbursement of expenses for the services requested, unless for reasons beyond our control.

The Luigi Veronesi Committee is teamed with the 10 A.M. ART, the art gallery that represents Luigi Veronesi, for the reception of all the necessary material for starting off the authentication and the archiviatiion procedure of the artist’s works.

The gallery’s task is to receive authentication and archiviatiion requests by collectors or professionals, to process these requests, to receive all the necessary material for starting off the authentication and the archiviatiion procedure for the works by Luigi Veronesi sent by the applicants, to emit invoices and to receive the payment for the reimbursement of expenses, to send the requests and material that has arrived at the Luigi Veronesi Committee, and to undertake the successive sending of the certificate of authenticity with the archiviatiion certificate that has been drafted, stamped, signed, and emitted under the exclusive responsibility of the Committee.
